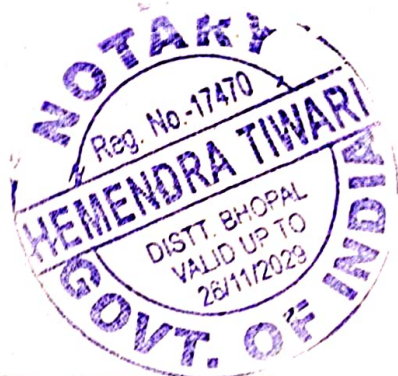

## Memorandum of Understanding



This Agreement dated 17<sup>th</sup> Day of July, 2025 entered between:


**Madhya Pradesh State Open School Education Board (MPSOEB), Government of Madhya Pradesh**, with its office at Shivaji Nagar, Bhopal [M.P.]-462011 acting through its authorized representative **Mr. Sachhidanand Prasad, Asst. Director, MPSOEB, Govt. of Madhya Pradesh**, hereinafter referred to as the “**FIRST Party**”.

And

**ABHYUTTHANAM WELFARE FOUNDATION** with registered office at 402 H.N. 21, Prateek Garden Colony, Baghsewaniya, Bhopal, MP, represented through its authorized representative **Sh Rahul Soni, Joint Secretary** (with a mutual desire to cooperate on training & capacity building in Cyber law, cybercrime, cyber forensics, Information security, IT Programs, cyber etiquettes and cyber security solutions etc and opportunities which are in line with the strengths and aspirations of the respective organizations), herein after referred to as the “**SECOND Party**”.

Now, the agreement is executed with the understanding that

1. The Second Party will work as Lead Co-Ordinator, knowledge partner and **Subject Matter Expert** with MPSOEB.
2. The Second Party will work as the nodal agency for conducting on training & capacity building in Cyber law, cybercrime, cyber forensics, Information security, IT, cyber etiquettes and cyber security solutions etc on behalf of MPSOEB.
3. That the Second Party will work under the over all supervision of the MPSOEB to achieve the objectives set out in this MoU. However, MPSOEB being the agency on whose branding & norms the work set out under this MoU would be carried out reserves the rights to investigate and call for any papers, proposal, documents sent to any department / Person on behalf of MPSOEB or issue any directions related to the objectives as setout in this MoU, which has to be complied with by SECOND Party and hence, decision of MPSOEB would be final on all matters concerning this MoU.
4. It is also understood that the Second Party will not commit anything to anyone on behalf of MPSOEB without the explicit approval in writing of MPSOEB representative. Any such commitments made on behalf of MPSOEB without

approval would be dealt with as per existing law and MPSOSEB has the right to recover damages who has given such a commitment without the explicit approval of MPSOSEB.

5. Quarterly report of progress has to be submitted by the SECOND Party on the progress in the prescribed format duly agreed by both Parties.

A. OBJECTIVES:

The objective of this MoU is to establish a framework of collaboration and cooperation between MPSOSEB and the Second Party with a mutual desire to work together in the areas of:

- Training and capacity building in **Cyber Law, Cybercrime investigation, Cyber Forensics** and cyber security domain.
- Education and awareness in **Information Security, Cyber Etiquettes, Cyber Safety**, child rights awareness and child protection etc.
- Development and dissemination of **cyber security awareness modules**
- Training and capacity building in IT Programs listed by NASSCOM, NIOS and other such agencies.
- Leveraging the strengths and aspirations of both organizations for mutual benefit and societal impact

B. AREAS OF COLLABORATION


The collaboration will include, but is not limited to:

- Designing and conducting training programs, workshops, and seminars for students, educators, and professionals
- Joint development of curriculum and resource material related to cyber safety and IT literacy.
- Implementation of awareness campaigns and community outreach programs
- Offering certification programs in areas of mutual interest.
- Exchange of knowledge, expertise, and technological resources

C. ROLES AND RESPONSIBILITIES

**MPSOSEB shall:**

- Facilitate access to its network of schools, learners, and educators
- Provide administrative and logistical support for program implementation

- Facilitate in conducting offline examination wherever applicable or mutually agreed between both parties.
- Issue joint certificates (where applicable)


**Second Party shall:**

- Prepare the certification programs, course content, study material and promotional matters as per the best in industry after approval of MPSOSEB.
- Design and deliver relevant training modules and workshops alongwith study material.
- Develop or provided the study material available in market based on the course content in electronic form on official channel.
- Three nos of hard copy of each course (including change in version) willl be provided for Library of MPSOSEB with no extra cost.
- Deliver relevant training modules and workshops alongwith study material which are designed by MPSOSEB.
- Deploy qualified trainers and experts in the respective domains
- Conduct regular assessments, feedback mechanisms, and reporting
- Bear responsibility for quality assurance and impact evaluation of the training programs
- Organize online / offline examination of certification programs under supervision of MPSOSEB limited and as per the standards of MPSOSEB.
- The weightage of online and offline examination shall be 20% and 80% respectively or otherwise mutually agreed by both parties duly approved and vetted by MPSOSEB.
- The Lead-coordinator shall provide the study material in soft form during the programs. Option for hard copy of study material on payment basis.

**D. PAYMENT TERMS**

The financial sharing will be decided mutually on project basis.

E. EXERCISING AUTHORITY


On behalf of MPSOSEB Director or his representative and on behalf of the agency, its Director/CEO/President /Secretary or a representative duly empowered will act as the exercising authorities, for operating the various provisions of this MOU on behalf of their respective organizations. All formal communications will be exchanged only through these nominated representatives.

F. DURATION AND TERMINATION

- 1) This MoU shall remain in effect for a period of **three (3) years** from the date of signing and may be extended upon mutual agreement.
- 2) Either Party may terminate this MoU by giving **60 days' written notice** to the other Party.
- 3) Termination of this MoU shall not affect any project or obligation already in progress unless mutually agreed.

G. GENERAL

- 4) Confidentiality: In the course of fulfilling the mutual responsibilities under this MOU, there will be a sharing of information of confidential nature. Both parties hereby agree to maintain such information relating to methods, trade secrets, ideas, products, services, processes, techniques and other proprietary information in strict confidence and not divulge these to any third party without the express consent of the other party except as may be necessary in the course of fulfilling mutual responsibilities in this MOU. This clause of confidentiality shall extend to the parties employees and associate / subsidiary companies / concerns and agents, if any.
- 5) Notices: All notices and communications concerning this MOU shall be sent to the respective addresses of the parties as above.
- 6) Assignment: Neither party shall assign any or all their rights and obligations under this MOU without the prior written consent of the other.
- 7) Amendments: Any amendments to this MOU shall be in writing and signed by both the parties.
- 8) Ownership: Intellectual property rights, titles or ownership of any products, proprietary information or technology will not be transferred from one company

to another on account of use of the same as part of any work under this MOU and shall always remain with the original owner of the same.

- 9) Costs: All the parties shall bear their respective costs arising out of performance of their obligations under this MOU.
- 10) Resolution of Disputes: Any dispute(s) arising out of or in connection with this MOU shall be resolved amicably between the authorized representatives of both the parties failing which such dispute(s) shall be referred to the Director , MPSOSEB for settlement.
- 11) Commitments: MPSOSEB or the agency shall make commitments or bind the other party in any manner with any customer only with prior written consent of the other party.
- 12) Force Majeure: Neither MPSOSEB nor agency shall be liable for non-performance of any or all their obligations under this MOU due to reasons of "Force Majeure" and / or reasons beyond their reasonable control.
- 13) Integration: This MOU contains the entire understanding between the parties and supersedes any prior written or oral MOUs between them.
- 14) Waiver: No failure or delay on the part of either party in the exercise of any right or privilege hereunder shall operate as a waiver thereof or of the exercise of any other right or privilege hereunder, nor shall any single or partial exercise of any such right or privilege preclude other or further exercise thereof of any other right or privilege.
- 15) Severability: If any provision of this MOU is held to be ineffective, unenforceable or illegal for any reason, such decision shall not affect the validity or enforceability of any or all of the remaining portions thereof.
- 16) Non-Solicitation: During the term of this MOU or termination, neither party shall, without the prior written consent of the other party, canvass or solicit for direct or indirect employment of any employee of each other or proceed with any application by or on behalf of that employee for direct or indirect employment. Neither party shall procure any third party to do any of the aforesaid acts.
